Section 4 First Aid Measures

> Description of First Aid Measures

> Specific Hazards Arising from the Substance or Mixture

- 1 Prevent further leakage or spillage if safe to do so.

> Methods and Materials for Containment and Cleaning Up

- 1 Absorb spilled material in dry sand or inert absorbent. In case of large amount of spillage, contain a spill by bunding.
- 2 Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
- 3 Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.
